

BUCKS COUNTY FREE LIBRARY MINUTES OF THE REGULAR MEETING OF JULY 19, 2022

The Regular Meeting of the Board of Directors of the Bucks County Free Library was held at the Bensalem branch. The meeting was called to order at 6:00 p.m. Present were: Constance Moore, President; Anthony Bush, Vice President; and Amy Masgay, Georgette Helbling, and Brian Reimers, Board Trustees; Martina Kominiarek, Chief Executive Officer; John Doran, Chief Financial Officer; Joe Thompson, Chief Operating Officer, and Jessica Gruber, Public Services Director.
